## A FEW WORDS FROM OUR BOARD CHAIR. . .


Dear Friends:

Big Brothers Big Sisters of Colorado's 2009 achievements were exceptional in a number of ways. While it goes without saying that the economic climate created unprecedented challenges for nonprofits in our community, I am pleased to report that Big Brothers Big Sisters of Colorado ended the year with a significant bottom line surplus and healthy cash position, and received the largest single gift from an individual donor in the organization's history.

Big Brothers Big Sisters recruits, trains and matches volunteer mentors (Bigs) with children (Littles) who live in low income, single-parent homes. One-third of the children we serve have an incarcerated parent.\*

### MISSION

Help children reach their full potential through professionally supported, one-to-one, volunteer mentoring relationships with measurable impact.

### NEED

There are over 35,000 elementary school-aged children living in low income, single-parent homes in metro Denver and Colorado Springs.

### PROGRAMS

#### COMMUNITY BASED MENTORING

Bigs and Littles choose their own activities and get together several times per month over the course of a year. Staff members support these relationships, plan supplemental mentor trainings and match events, and provide suggestions for low-cost activities.

#### SPORTS BUDDIES MENTORING

Bigs and Littles participate in agency supervised and organized match activities including attending and playing team sports.

#### SITE BASED & MILITARY MENTORING

In Colorado Springs, Bigs and Littles meet regularly at the same location to participate in agency-organized activities. Programs include School Based Mentoring, Falcon Club and Operation Mentor.

\*Children with an incarcerated parent are part of the Reach Program within our Community Based and Sports Buddies Mentoring.



# Mentoring works!



## MENTORING CHANGES LIVES

In 2009, the children Big Brothers Big Sisters of Colorado served experienced positive outcomes in various areas of their lives. Our survey of Littles' parents and Bigs showed that:

### SOCIAL SKILLS & SENSE OF FUTURE

- 88% Improved their self-confidence
- 77% Were better able to express their feelings
- 72% Had increased interests or hobbies
- 72% Improved their sense of the future

### RELATIONSHIPS

- 66% Improved relationships with peers
- 63% Improved relationships with family
- 69% Improved relationships with adults

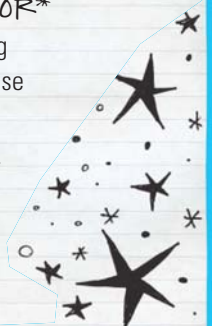
### EDUCATION

- 63% Improved their attitude toward school
- 68% Improved their academic performance
- 63% Improved their class participation
- 60% Improved their classroom behavior

### NEGATIVE & DELINQUENT BEHAVIOR\*

- 61% Increased their ability to avoid early parenting
- 57% Increased their ability to avoid substance abuse
- 54% Increased their ability to avoid delinquency

*\*Big Brothers Big Sisters of Colorado measured the percentage of youth who show improvement in the above areas. Due to the young age of the youth served, many children showed no difference in their ability to avoid delinquency, substance abuse and early parenting.*



## MENTORING IMPROVES OUR COMMUNITY

### COMMUNITY NEED

- One-quarter of Colorado students do not graduate from high school,<sup>1</sup> resulting in higher unemployment, poverty, divorce rates, and demand for public assistance, as well as more crowded jails and more single parents who have children who drop out of high school.<sup>2</sup>
- Colorado would have an additional \$830 million in accumulated wealth if all heads of household were high-school graduates.<sup>3</sup>

### BIG BROTHERS BIG SISTERS' IMPACT

In 2009, Harris Interactive® conducted a survey on behalf of Big Brothers Big Sisters of America. This survey of adults who had a Big Brother or Big Sister as a child (adult Littles) illustrated just how impactful the program can be. In short, the majority of Adult Littles said that having a Big helped them:

- Reach a higher level of education than they thought possible (65%)
- Set higher goals than they would have on their own (77%)
- Learn right from wrong and the importance of helping others (75%)
- Feel better about themselves (90%)

In addition, the majority said their Big:

- Kept them from dropping out of high school (52%)
- Changed their perspective on what they thought possible in life (81%)
- Provided stability when they needed it (90%)

# 2009 Highlights

In 2009, Big Brothers Big Sisters of Colorado supported **1,870** high-quality one-to-one mentoring relationships. Mentors spent **92,326** hours with their Littles - valued at approximately **\$1,870,000**.



## PROGRAM

We continued to focus on our target populations while improving program impact by:

- Creating Operation Mentor with Fort Carson Army Base to respond to the growing need of children with deployed parents.
- Launching an Aurora Sports Buddies to serve more children from Aurora Public Schools with new funding from Bonfils-Stanton Foundation and the Office of Juvenile Justice.
- Increasing average length of Big/Little Community Based Mentoring matches to 18.4 months, a 15.7% increase.

## FINANCIAL

We exceeded 2009 revenue budget and finished the year with a bottom-line surplus by:

- Reducing costs including focusing on core programs, moving to smaller office space, increasing operating efficiencies and reducing overall expenses.
- Diversifying revenue sources and significantly increasing the portion of the budget raised from individual donors.
- Launching online giving campaigns to appeal to new donor demographics.

## COMMUNITY

We worked within the community to increase awareness of our programs and identify key partners by:

- Strengthening partnerships with local school districts to better serve the community and collect school data to better understand the impact of our programs on education.
- Launching a "Be Big" awareness campaign in the Colorado Springs market.
- Continuing agency Inclusiveness Initiative and increased ethnic diversity among mentors and board members.



Little Brother Sam is matched with Big Brother Taylor. Sam's mother, Melissa, was so moved by the changes she saw in her son after only a few months of being matched, she wrote Taylor a letter to say thank you:

Taylor,  
When Sam was matched with you, his life changed for the better. Your interaction, kindness, love and listening ear have given him enough self confidence in school and in life that he tries harder. He believes in himself.

Last year, Sam had to repeat first grade math but now, he often tells me, "Taylor and I are math geeks. We're the same." I'm thrilled beyond belief that his math grade has improved to "meets expectations."

Sam has not only improved in school, he's improved as a little boy on his way to becoming a man. When we return home from shopping, he often now tells me, "Mom, you go inside and relax; I'll bring in all the groceries." Where did that little boy come from?!

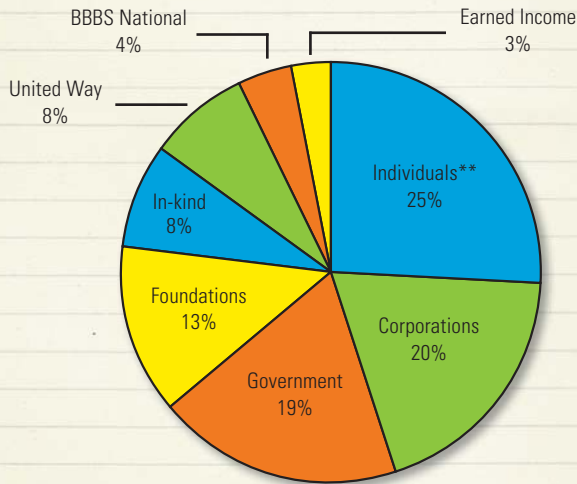

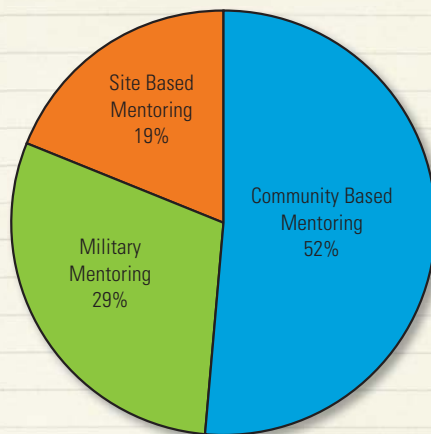
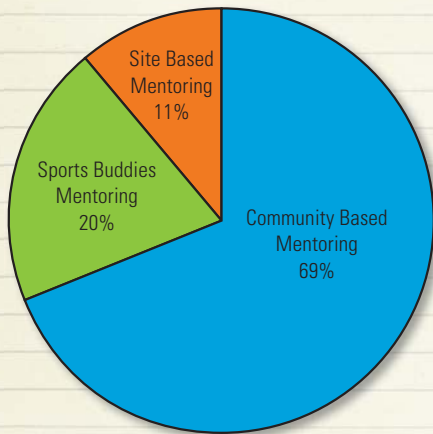
## 2009 PUBLIC SUPPORT & REVENUE

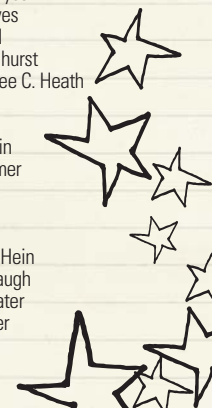

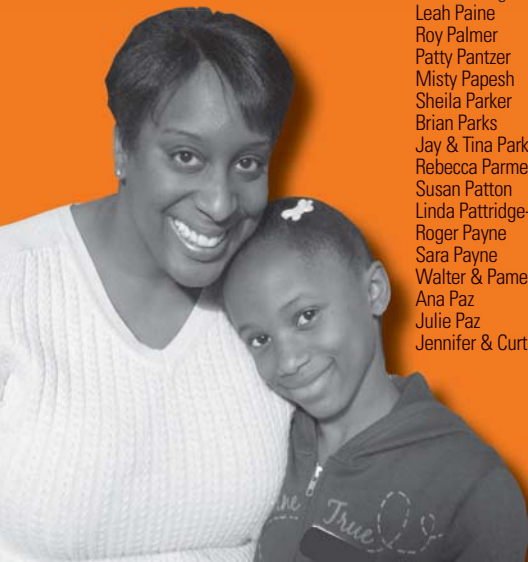
