Our high-impact mentoring programs are delivered by volunteers and supported by BBBSC staff. The IRS does not allow the reporting of the value of these volunteer-provided services in our financial statements, but these services are critical to the Big Brothers Big Sisters of Colorado Mentoring Program operations. In 2021, BBBSC volunteers provided 63,965 volunteer hours valued at \$1.9 million. This significant value results in lower administrative/fundraising-related expense percentages than reflected in the 990, Part IX. When the reported program-related expenses are combined with this volunteer-provided added value, our program-related expenses equal 76% of our total expenditures. For every \$1 invested in BBBSC, the community receives a \$4 benefit either directly or in future avoided costs.

-Celebrated littles who graduated from high school in 2021; many are the first in their family to reach this milestone
